What is this product?

Type

Investment Fund. This product is offered in combination with an insurance product.

Term

This Fund is open ended. The recommended holding period is 20 years.

Objectives

The investment in this Fund should be considered as long-term. The value of your investment will fluctuate according to the performance of the Fund. The Fund invests globally, including Cyprus, in growth investments as equities and equity mutual funds, but also to a lesser extent to bonds and bond mutual funds. In particular, emphasis is given to sectors with long-term growth prospects. The Fund has no guaranteed return and previous performance does not guarantee future returns.

Intended retail investor

The Fund is aimed at investors with a long-term horizon over 10 years, who are willing to take medium investment risk and aim at achieving long-term capital appreciation using mainly growth investments.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 20 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. Information regarding the surrender charges can be found in section "How long should I hold it and can I take money out early?"

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the manufacturer is not able to pay you. We have classified this product as **4** out of 7, which is a **medium** class. This rates the potential losses from future performance at a **medium** level, and poor market conditions are **very unlikely** to impact the capacity of the manufacturer to pay you. This product does not include any protection from future market performance so you could lose some or all of your investment. Cost over time
